1. The licence expiry date is 30 June 2018.
2. Licensee shall comply with all relevant legislation and Shire local laws.
3. Provision of public liability insurance cover to the value of \$10,000,000 (\$10 Million) at all times.
4. The only trading activities permitted on the area of application are the approved identified commercial activity.
5. All rubbish and waste must be removed from the site. It is not to be placed in any public bins. Adequate waste receptacles are to be arranged prior to trading.
6. All food stalls and vans to comply with the Food Act 2008 and associated legislation.
7. Shire of Broome reserves the right to vary licence conditions as required, or to revoke this licence at any stage in accordance with the Trading, Outdoor Dining and Street Entertainment Local Law 2016.
8. Stallholders are required to obtain the event organiser's approval prior to trade.
9. Trading at St Mary's School premises to be only in concurrence with school fetes.
10. No sign or advertising device is to be erected on trading site or street reserve.
11. The power supplying equipment must not cause any noise nuisance.
12. No trading should occur in front of the Chinese section of the cemetery.
13. Adhere to the traffic management plan submitted addressing management of traffic flow, unrestricted pedestrian footpaths and maintenance of car park.
