4. PUBLIC QUESTION TIME

The following questions were received from Carmel Leahy prior to the meeting Question One (1)

My questions relate to RFQ21-31 Cable Beach Foreshore Redevelopment Detail Design

The Shire's Caretaker period starts in just seven hours. I have been speaking to the Electoral Commission. It is normal practise for a governing body including a Shire Council to suspend important decision making once the electoral process is underway.

Nominations for Shire opened on Thursday 2nd September. The electoral process is well underway. We have three candidates sitting on the council. Is it ethical for the Shire to be holding a Special Council Meeting to consider a matter of importance and making decisions just seven hours before your Caretaker Period begins?

The point of Council's Election Caretaker Policy is to maintain a high standard of integrity during the election period. The matter for Council consideration is in compliance with this policy.

Question Two (2)

Why is the Shire holding a Special Council Meeting to make decisions about the Cable Beach Foreshore Redevelopment Detail Design just seven hours before their Caretaker Period and already in the midst of the electoral process rather than waiting for the electoral process to be completed?

The meeting has been called in accordance with Council's Election Caretaker Policy.

The matter was programmed to be tabled at the August OMC, however due diligence undertaken by officers regarding clarifications on submissions has ultimately extended this timeframe.

A Special Council meeting has been called at this time primarily to permit Council consideration of this matter to enable the procurement process to be completed to appoint the preferred consultant to undertake detailed design on the Cable Beach Foreshore Redevelopment. This procurement process commenced in early July 2021. It is historical practice to call Special Council meetings to award tenders to ensure timely procurement occurs and budgeted items are completed within the Financial Year.

This Project is within Council's endorsed Strategic Community Plan, Corporate Business Plan and 3 Year Covid-19 Recovery Plan. It should be further noted the detailed design is within Council's endorsed annual budget. It is the CEO's responsibility to so far as reasonably practical abide by the Caretaker Election Policy. This has occurred. It is also the CEO's responsibility to complete budgeted items within the financial year.

The following questions were asked by Beau Biddy at the meeting Question One (1)

Will a coastal sediment specialist be engaged as part of the Cable Beach Foreshore Redevelopment Detail Design stage to predict how sand and the sediment will be effected by the proposed development?

The Detailed Design Stage will investigate all additional studies that are required to meet Australian Standards and regulatory requirements. If this process identifies that a sediment movement study is required, then an appropriately qualified coastal sediment specialist would be engaged.

Question Two (2)

Has any estimate of the cost of sand renourishment been done in relation to the Cable Beach Foreshore Redevelopment and was a coastal sediment specialist engaged to assist with this calculation?

Response provided by Peter Collins, Manager Engineering

Seashore Engineering have completed the initial concept design for protection options of Cable Beach which includes sand renourishment. These produced estimated volumes of sand required to provided appropriate protection and high level cost estimates. Refer to Council Agenda Item 9.2.1 – Cable Beach Coastal Protection Options and Geotechnical Investigations at the Ordinary Meeting of Council held on 24 June 2021.

Exact volumes and detailed cost estimates will be produced during the Detailed Design Stage.
